Appendix

Practical Requirements

Matching

While every effort is made to ensure satisfaction, exact colour or design matching cannot be guaranteed between different widths of carpet due to manufacturing tolerance over which We have no control. Neither can exact matching be guaranteed between the flooring supplied and the sample displayed in the showroom.

Furniture and Carpets

To facilitate speedy and efficient fitting, rooms to be fitted must be cleared of furniture, effects and old floor coverings prior to the fitter's arrival. The cost of such clearance may be charged as extra if required. Should assistance be required to move such items such as pianos and clocks, We do not accept responsibility for re-tuning and rebalancing these items.

Plain Carpets

Plain carpet is subject to shading with use due to pile pressure. This is characteristic of this type of carpet and does not affect the durability of the carpet.

Wood / Laminate / LVT products

Please refer to Our additional information sheet regarding these products as these are subject to settling in periods and wood in particular will mellow with age causing a slight colour change.

Dont forget to:

It should be noted that when calculating the quantities for wood/ laminate or luxury vinyl tile/plank products, a small percentage is allowed for wastage to the nearest fixed pack size - as recommended by manufacturers. Wastage refers to pieces that have been cut from full planks or tiles in order to carry out the correct installation and is not a result of incorrect planning and estimating. In some cases the fitter is able to carry out the installation with less wastage and this may result in a part or full box being left over. It should be understood that We cannot refund for wastage as all materials are ordered in for each specific job as per correct recommendation and have no re-sale value.

Natural Floorcovering

Many of these products have slight variations in the manufacturing as they are natural products, and these variations are part of the appeal. These products require a settling in period as they are sensitive to the environment in which they are fitted. A separate information sheet is available for these products upon request, but we draw particular attention to the fact that all natural products will fade with time, particularly if fitted in direct sunlight.

Pipes, Cables and Radiators

It is Your responsibility to notify the Floor Fitter in writing of the location of any pipes or cables that might be damaged during the fitting. No responsibility is accepted by Us for damage to underfloor pipes or cables, or for consequential damage to

property or fittings unless written notification has been given as stated above. Furthermore, no responsibility is taken by Us or the Floor Fitter for leaky radiators post installation.

Floors and Doors

Should solid floors not accept concrete nails, and drilling and plugging or sticking is necessary, an additional charge will be made according to circumstances. Should internal doors require easing.

in situ. a charge will be made per door (prices on application). the Floor Fitter(s) reserves the right of refusal to carry out door easing in cases where in their professional opinion a carpenter would be required. Our quotations/estimates are based on what we are able to see of the subfloor at time of measuring and based on the presumption that there will be no extra materials or labour needed above that which is estimated to complete the work.

Should Our Floor Fitter/s discover that, due to unforeseen issues with the subfloor, extra work and materials need to be applied to make good the subfloor ready for the new floorcovering then all extra costs will be Your responsibility.

Maintenance on LVT's, Wood & Laminate

Please refer to manufacturer's instructions.

Satellite Cables, Televisions and Computers

We are not responsible for loss of signal or data due to items being moved in the process of installing your floor covering or carrying out sub-floor preparation work.

Light Fittings in Rooms below

We are not responsible for spotlights or light fittings moving or falling out of ceiling from room/s below during, or after, installation of new flooring.

Appliances

Unless agreed in advance and all related costs accepted by You, our Floor Fitter/s do not move appliances – cookers, fridges, washing machines, tumble dryers, dishwashers - and it is Your responsibility to ensure that the area of which Products are to be installed is clear. Our Floor Fitters will fit up to the appliance only and under kick boards removed prior to their visit.
